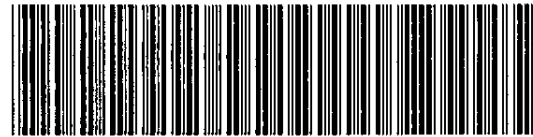

OF

The undersigned, a duly licensed Doctor of Dentistry in the State of Florida, hereby makes, subscribes, acknowledges, and files with the Division of Corporations, Department of State of the State of Florida these articles of incorporation for the purpose of forming a Professional Service Corporation in accordance with the laws of the State of Florida.

**ARTICLE I
NAME**

The name of this corporation shall be ROBERT H. MCCLARY, D.D.S., P.A.

**ARTICLE II
TERM OF EXISTENCE**

This corporation shall begin existence on the date of filing of these articles with the Division of Corporations, Department of State of the State of Florida, and shall have perpetual existence thereafter.


