**ARTICLES OF AMENDMENT  
TO ARTICLES OF INCORPORATION OF  
MAYBONE MEDICAL, INC.**

Pursuant to Sections 607.1001, 607.1003 and 607.1006 of the Florida Business Corporation Act, the undersigned corporation, **MAYBONE MEDICAL, INC.**, a Florida corporation (the "**Corporation**"), adopts the following Articles of Amendment to amend its Articles of Incorporation:

1. The name of the Corporation is Maybone Medical, Inc.
2. Article I of the Articles of Incorporation of the Corporation is hereby amended in its entirety to read as follows:
