Initially, this corporation is authorized to issue 10,000 shares of common stock at \$ 0, 01

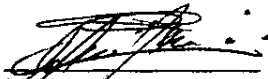

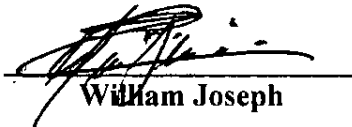
