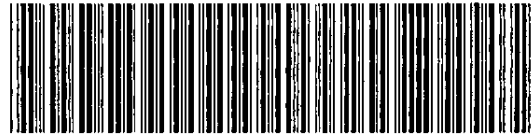

ARTICLE V – INITIAL REGISTERED OFFICE


