**ARTICLES OF INCORPORATION
OF
FTFFA COOPERATIVE CORPORATION**

The undersigned, acting as the Incorporator of **FTFFA COOPERATIVE CORPORATION**, a Florida corporation (the "Corporation"), pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for the Corporation:

ARTICLE I

Name

The name of the Corporation is **FTFFA COOPERATIVE CORPORATION**.

ARTICLE II

Principal Office

The principal office and mailing address of the Corporation shall be 316 West Central Avenue, Suite 200, Winter Haven, Florida 33880.

ARTICLE III

Purpose

The Corporation is organized for the purpose of transacting any or all lawful businesses for which corporations may be incorporated under Chapter 607, Florida Statutes.

ARTICLE IV
