**ARTICLES OF INCORPORATION
DADE COUNTY GRASS CHOPPERS INC.**

The undersigned Incorporator, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation is DADE COUNTY GRASS CHOPPERS, INC.

ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS

**ARTICLE III. DURATION AND COMMENCEMENT
OF CORPORATE EXISTENCE**

The corporation shall exist perpetually. The corporate existence shall commence upon the filing
of these Articles of Incorporation with the Department of State.

ARTICLE IV. NATURE OF BUSINESS

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE V. CAPITAL STOCK

The corporation is authorized to have outstanding one class of stock, to be designated as
Common Stock. The maximum number of shares of Common Stock which the corporation is authorized

and there shall be no cumulative voting. Holders of Common Stock shall have pre-emptive rights to
subscribe to the corporation's securities and are entitled to receive the net assets of the corporation upon
dissolution.

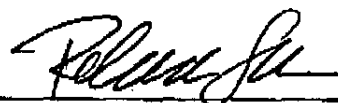
