ARTICLE I: NAME

The name of the corporation shall be: A Magic Bounce House - Party Rentals, Inc.

ARTICLE II: DURATION

The term of existence of this corporation is perpetual.

ARTICLE III: PURPOSE OF THIS CORPORATION

This corporation is organized to engage in, or transact the business of arcade, party and games and all business activities related thereto, and all other lawful business and/or activities for which corporations may be incorporated under the laws of the United States of America, The Florida General Corporation Act, the State of Florida, and/or any other state, country, territory, or nation.

The corporation shall initially have one (1) Director, which may be increased from time to time through appropriate changes in the By-Laws, but the number of Directors shall never exceed Five (5) Directors. - (D) The corporation shall indemnify each director and officer of the corporation against all or any portion of any expenses reasonably incurred by him/her in connection with or arising out of any action, suit or proceeding in which he/she may be involved, by reason of he/she being or having been a director or officer of the corporation [whether or not he/she continues to be a director or officer at the time of incurring such expense(s)], to the full extent permitted by and subject only to the limitations and provisions of the laws of the State of Florida and the United States of America.
