ARTICLES OF INCORPORATION 11 EEB -8 PM 2: 08

OF STATE INSURANCE AND ASSOCIATES, INC. TALLAHASSEE FLORIDA

The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I - NAME AND ADDRESS OF CORPORATION

The name of the corporation is BRICE INSURANCE AND ASSOCIATES, INC. The Corporation shall be referred to in this instrument as "the Corporation"; these Articles of Incorporation as "Articles"; and the By-Laws of the corporation as "By-Laws".

ARTICLE II - TERM OF EXISTENCE

The period of duration of the corporation is perpetual.
