ARTICLES OF INCORPORATION OF MAJOR RECYCLING, INC

ARTICLE I

Name. The name of this corporation is MAJOR RECYCLING, INC.

ARTICLE II

Duration. The corporation shall be perpetual.

ARTICLE III
