**ARTICLES OF INCORPORATION
OF
DONALD S. MILES, P.A.**

The undersigned, for the purpose of forming a corporation under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I -Name

The name of the corporation is Donald S. Miles, P.A.

ARTICLE II -Business

The corporation's sole business is the rendering of professional real estate services to the general public.

ARTICLE III -Stock

The total number of shares of stock which the corporation will have authority to issue is One Thousand (1,000) shares of One Dollar (\$1.00) per share par value common stock. All of said stock will be payable in cash or real or personal property or such consideration as may be fixed by the shareholders.

ARTICLE IV -Registered Office and Agent

The initial address of the principal and registered office of the corporation is 10762 SW 62nd. Terrace, Ocala, Florida 34476.

ARTICLE IX -Preemptive Rights



ARTICLE X -Amendment

This corporation may amend its certificate of incorporation in any respect, provided that only such provisions shall be inserted by amendment as would be lawful

and proper in an original certificate of incorporation made at the time of making such amendment. Every amendment shall be proposed by a stockholder and approved at a stockholder' meeting by not less than a majority of the stock entitled to vote thereon.




