**ARTICLES OF INCORPORATION OF**  
**TURF DIETITIAN, INC.**


1. ARTICLE IV of the Articles of Incorporation of TURF DIETITIAN, INC. is amended to read as follows:

ARTICLE IV  
CAPITAL STOCK

This corporation is authorized to issue 100 shares of common stock divided into two (2) classes as follows: Class A common stock, consisting of fifty (50) shares of par value of \$1.00 each; and Class B common stock, consisting of fifty (50) shares of par value of \$1.00 each. The holders of Class A common shares shall have exclusive voting power over all issues concerning the corporation. The holders of Class B common shares shall not have any voting power. Both Class A and Class B common shares shall have identical rights to distribution and liquidation proceeds of the corporation.

2. The foregoing amendment was adopted by the shareholders and directors of this corporation on July 12, 2017.


