ARTICLES OF INCORPORATION

OF

LAMEX AGRIFOODS, INC.

The undersigned incorporator, for the purpose of forming a corporation (hereinafter referred to as the "Corporation") under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

Article I: The name of the corporation shall be Lamex Agrifoods, Inc.

Article II: The principal place of business and mailing address of this corporation shall be Bayview Center, 80 SW 8th Street, 20th Floor, Miami, Florida 33130.

Article III: The number of shares of stock that the corporation is authorized to have outstanding at any one time is One Thousand (1,000), all of which are of a par value of One Cent (\$.01) each and classified as Common shares.

DENY PREEMPTIVE RIGHTS

Article VI: No holder of any of the shares of the corporation shall, as such holder, have any right to purchase or subscribe for any shares of any class which the corporation may issue or sell, whether or not such shares are exchangeable for any shares of the corporation of any other class or

classes, and whether such shares are issued out of the number of shares authorized by the Articles of Incorporation of the corporation as originally filed, or by any amendment thereof, or out of shares of the corporation acquired by it after the issue thereof; nor shall any holder of any of the shares of the corporation, as such holder, have any right to purchase or subscribe for any obligations which the corporation may issue or sell that shall be convertible into, or exchangeable for, any shares of the corporation of any class or classes, or to which shall be attached or shall appertain to any warrant or warrants or other instrument or instruments that shall confer upon the holder thereof the right to subscribe for, or purchase from the corporation any shares of any class or classes.
