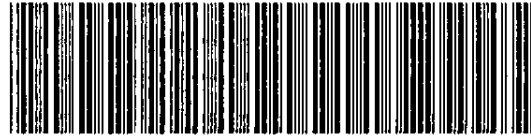

ARTICLE I.
