ARTICLES OF INCORPORATION

OF

We the undersigned for the purpose of incorporating under the laws of Florida, by and under the provisions of the Statutes of the State of Florida, providing for the formation, liabilities,, rights, privileges and immunities of corporation profit, file these Articles of Incorporation.

ARTICLE I

The name of this corporation is: USA NORTH AMERICA TRADE CORPORATION Located at 16919 NORTH BAY ROAD UNIT 110 SUNNY ISLES BEACH, FLORIDA 33160

ARTICLE II

The general nature of the business or businesses to be transacted is as follows:

Section 1: To buy, sell, mortgage, lease, encumber, alienate or otherwise Deal in real

Property and to construct thereon, cause to be constructed thereon or otherwise improve

real property or personal property, including the doing of any And all business and

Contracting incidental or connected therewith and doing and performing any and all acts

necessary, proper or convenient for or incidental to Furthermore or the carrying out of the

SECTION 4: To engage and carry out any business or businesses and every act or deed pertaining thereto, either directly or indirectly which is not prohibited by the laws of the State of Florida or in any other State of the United States or in any foreign country. To do any and all things necessary, suitable, usoful, proper or admissible for the accomplishment of any one of the purposes or for the attainment of any of the objects or further exercise of the powers berein set forth, whether herein specified or not, either alone or in connection with other firms, individuals or corporations either in this state or throughout the United States and elsewhere.

ARTICLE III

The foregoing clauses shall be construed both as objects and powers but no recitation, expression or declaration of specific or special powers or purposes herein enumerated shall be deemed to be exclusive But it is hereby expressly declared that all other lawful powers not inconsistent herewith are hereby included.

ARTICLE IV

Any unused stock or such additional authorized issue of new stock or of other securities convertible into stock may be issued and disposed of pursuant to resolution of the Board of Directors to such other persons, Firms, corporations or associations.

ARTICLE V

The maximum number of shares of stock that this corporation is authorized To have outstanding at any time shall be ONE THOUSAND (1,000) SHARES OF ONE DOLLAR (\$1.00) par value, unless duly changed in accordance with the laws of The State of Florida. It is the intention of this corporation that the stock issued shall qualify as "Section 1244 Stock" as such term is defined in the Internal Revenue Code and the Regulations issued there under.

ARTICLE VI

Every shareholder upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds shall have the right to purchase his prorate share thereof (as nearly as may be done without issuance of fractional shares) at the price it is offered to others.


