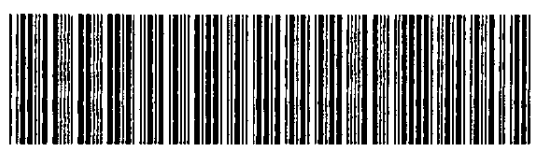

ARTICLE I – NAME
