ARTICLE 1

NAME OF THE CORPORATION

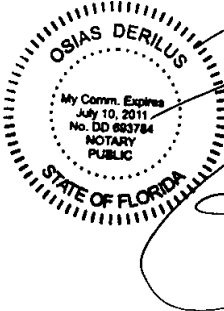
