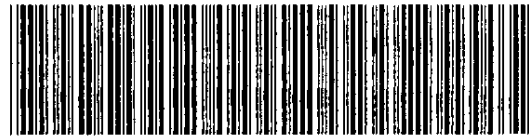

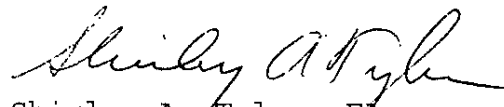

The undersigned subscriber to these Articles of Incorporation hereby forms a Corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be: E & J WEST INDIAN STORE, INC. The principal place of business will be 1838 49TH Street South, St. Petersburg, FL, 33707

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

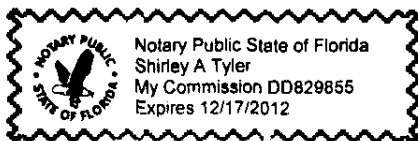
