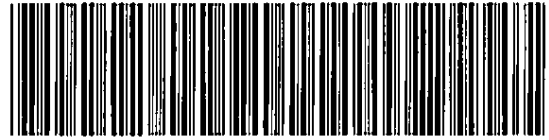


Dear Mr. Banfi and Mr. Nagy,


