ARTICLES OF INCORPORATION 201 OF TENDA, INC.

The undersigned incorporator to these Articles of Incorporation, a natural person, competent to contract, hereby forms a Corporation under the laws of the State of Florida.

ARTICLE I.

NAME

The name of the Corporation shall be TENDA, INC.

ARTICLE II.

PRINCIPAL OFFICE

The principal place of business and mailing address of this Corporation shall be: 9161 E. Bay Harbor Drive, Suite 8B, Bal Harbour, FI 33154.

ARTICLE III.

PURPOSES

The purpose for which the corporation is formed and the business and objects to be carried on and promoted by it are as follows:

INSPECTION OF BOOKS AND RECORDS


