ARTICLES OF INCORPORATION OF INTERCORPORATE RESEARCH LIMITED, INC.

THE UNDERSIGNED, acting as sole incorporator of INTERCORPORATE RESEARCH LIMITED, INC. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I. NAME

The name of the corporation is INTERCORPORATE RESEARCH LIMITED, INC.

ARTICLE II. SHARES

The authorized capital stock of the Corporation shall consist of 10,000 shares of common stock, par value \$0.01 per share. Each share of the Corporation's common stock shall have the same rights and preferences as each other share of the Corporation's common stock.
