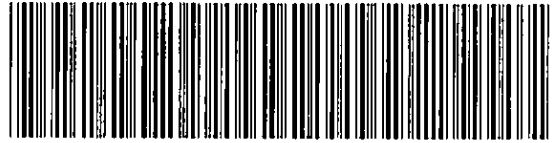

Pursuant to the provisions of 607.1008, Florida Statutes (the "FS"), this Florida Profit Corporation adopts the following amendment to its Articles of Incorporation:

- A. THE CERTIFICATE OF INCORPORATION IS: AMENDED
- B. TEXT OF AMENDMENT

"ARTICLE IX – NON-VOTING EQUITY SECURITIES

To the extent provided by Section 1123(a)(6) of chapter 11 of title 11 of the United States Code, this corporation shall not be permitted to issue any non-voting equity securities."

- C. DATE OF COURT ORDER APPROVING THE CERTIFICATE OF AMENDMENT; TITLE OF REORGANIZATION PROCEEDING IN WHICH THE ORDER WAS ENTERED; THE COURT HAD JURISDICTION OF THE PROCEEDING UNDER THE FOLLOWING FEDERAL STATUTE:

On February 4, 2024, Cano Health, Inc. and its subsidiaries, including Clinical Research of Hollywood, P.A., commenced with the United States Bankruptcy Court for the District of Delaware (the "Bankruptcy Court") voluntary cases pursuant to Chapter 11 of Title 11 of the United States Code.

This Certificate of Amendment has been deemed approved without the need for board of directors or stockholder approval pursuant to §607.1008 of the FS because it is to carry out the *Joint Chapter 11 Plan of Reorganization of Cano Health, Inc. and its Affiliated Debtors*, as confirmed on June 28, 2024 by order of the Bankruptcy Court.

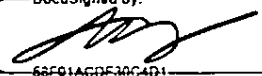
