ARTICLES OF INCORPORATION PASCO AIR CONDITIONING, INC.

Article One: NAME

The name of this corporation is CONDITIONING, INC.

PASCO SEE, FLORIDA

Article Two: Purposes

The corporation is formed for the purpose of providing quality commercial and residential air conditioning services and materials and for any other lawful purpose. The corporation may exercise all powers, rights and privileges conferred on corporations pursuant to the laws of the State of Florida.
