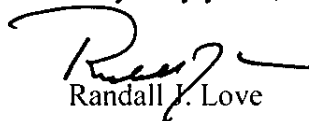

PASCO AIR CONDITIONING, INC.**

Article One:       NAME

The name of this corporation is PASCO AIR  
CONDITIONING, INC.

Article Two:       Purposes

The corporation is formed for the purpose of providing quality commercial and residential air conditioning services and materials and for any other lawful purpose. The corporation may exercise all powers, rights and privileges conferred on corporations pursuant to the laws of the State of Florida.

Article Three:     Registered Office and Agent

The address of the initial registered office of the corporation in the State of Florida is Randall J. Love, 5647 Gulf Drive, New Port Richey, Florida 34652. The initial registered agent is Randall J. Love.

Article Four:     Principal Office

(a) The business and affairs of the corporation shall be managed by a board of directors. The number of directors constituting the initial board of directors is

three and said directors shall be elected at the first meeting of shareholders.

(b) The number of directors of the corporation set forth in Clause (a) of this Article shall constitute the authorized number of directors until changed by an amendment of these articles of incorporation or by a bylaw duly adopted by the vote or written consent of the holders of a majority of the then outstanding shares of stock in the corporation.

(c) The director(s) shall have all the powers granted to them under Florida law.
