#### ARTICLES OF INCORPORATION

OF

#### **CLOCK MAKER, INC.**

#### ARTICLE I - NAME

The name of the corporation is Clock Maker, Inc., at 238 S. Wickham Road, Melbourne FL 32904 (Principal Office of Registered Agent).

#### <u>ARTICLE II - DURATION</u>

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.

#### ARTICLE III - PURPOSE
