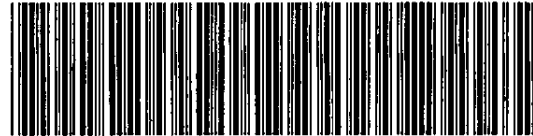

Attached please find the Articles of Amendment that I have been requested to file on behalf of the unauthorized changes to my business which I started in 2011.

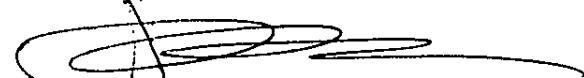
According to YOUR guidelines, first item listed...
