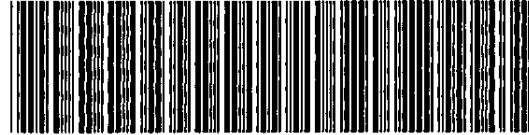

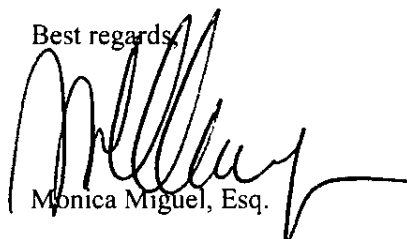

1. The current President, Jorge L. Del Villar, is hereby removed as President, and will hold a new office pursuant to paragraph 2.

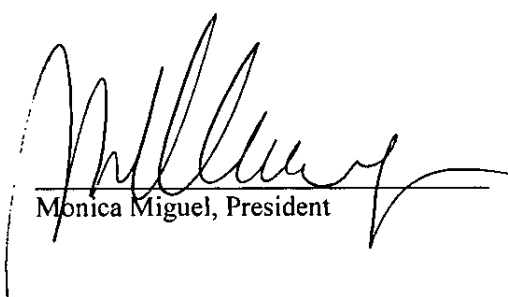
