ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this Corporation is 2670, Inc. Its principal office address and business mailing address is: 16 Driftwood Drive, Key West, FL 33040.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE
