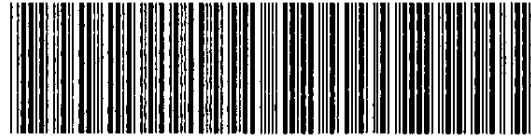

**ARTICLE I - Name**
