ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is KEYS FIRE EXTINGUISHERS, INC., and its principal place of business shall be located at 1607 Bogic Drive, Big Pine Key, Florida 33043, and the mailing address is P.O. Box 430624, Big Pine Key, Florida 33043.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.
