**ARTICLES OF INCORPORATION
OF
KUBI, INC.**

ARTICLE I

The name of the corporation is **KUBI, INC.** (hereinafter the "Corporation").

ARTICLE II

The address of the principal office and mailing address of the Corporation is c/o Burton B. Landy, One S.E. Third Avenue, 25th Floor, Miami, FL 33131.

ARTICLE III

The purpose for which the Corporation is organized is to transact any lawful business including distribution of services and products in the area of electronic processing and data, telecommunications and Internet in general.
