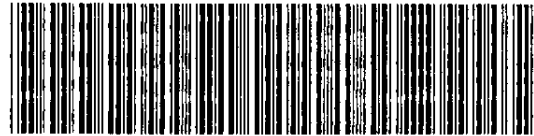



ARTICLE I. - NAME

The name of this corporation is **SUDHINDRA PUDUR, M.D.M.S., P.A.**



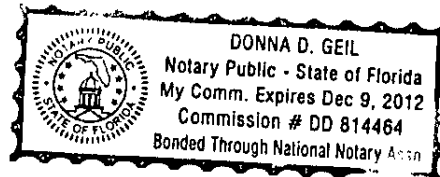
