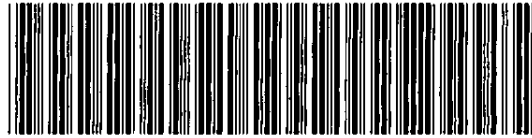

Name

The name of this corporation is OKEANIS TRADE, INC.

Article II
Principal Office Address
