ARTICLE XIV: PHYSICAL YEAR

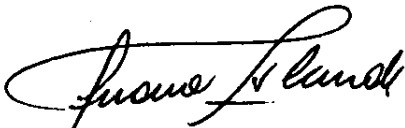

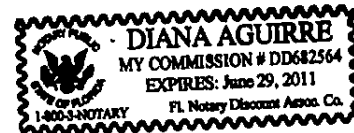

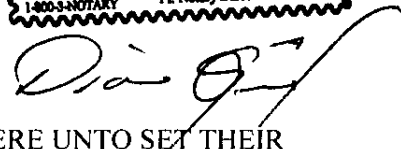
