
ARTICLE VIII

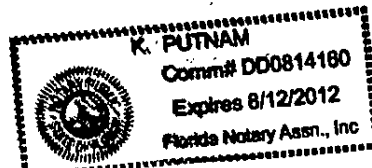


