ARTICLES OF INCORPORATION (PROFIT)

ANDRES F DIAZ, being of the age of eighteen (18) years old or more, does hereby make and acknowledge these Articles of Incorporation under and by virtue of the laws of the State of Florida.

1. The name of the Corporation shall be: King of Restoration Corp.
2. The number of shares the Corporation is authorized to issue shall be 100 shares all of one class designated as common stock, at \$ 1.00 per value.
3. The street address and county of the initial principal office of the corporation is: 15078 SW 104 St # 907 Miami, Fl 33196 -Miami Dade County and the name of the initial register agent at this address is: Andres F Diaz.
4. The number of the directors constituting the initial Board of Directors shall be one director and the name and address of the person whom is to serve as director until the first meeting of shareholders or until their successors are elected and qualified is: Andres F Diaz at 15078 SW 104 St # 907 Miami, Fl 33196.
5. To the fullest extent permitted by the State if Florida Business Corporation Act, as it exist or may hereafter be amended, no person who is serving or who has served as a director of the corporation shall be personally liable to the corporation or any of its Shareholders for monetary damages for breach of duty as a director.
