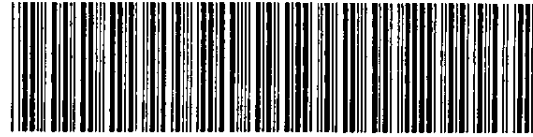

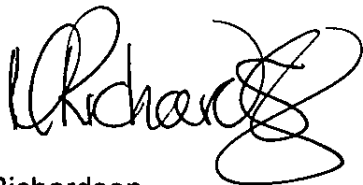

ARTICLES OF INCORPORATION OF

The shareholders of the corporation shall direct its affairs in lieu of a Board of Directors.

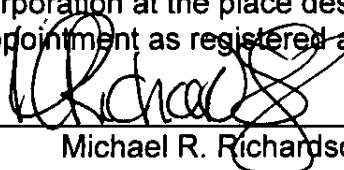
ARTICLE VII. INITIAL REGISTERED AGENT AND OFFICE

ARTICLE VIII. INCORPORATOR

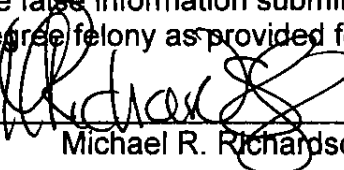
