ARTICLES OF INCORPORATION OF FOR Corp.

In compliance with the requirements of Florida Statutes Chapter 607, the undersigned, being a matural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

NAME

The name of this corporation is FDF Corp.

ARTICLE II

PRINCIPAL OFFICE

TERM OF CORPORATE EXISTENCE

PERMITTED ACTIVITY
