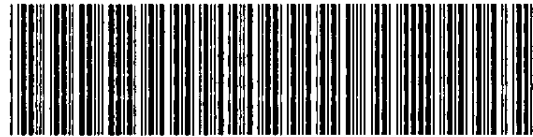



ARTICLES OF INCORPORATION
OF
W.C. FORESTRY & WILDLIFE, INC.

The undersigned, acting as incorporator of a corporation
under the Florida General Corporation Act, herewith adopts
the following articles for such corporation.

ARTICLE I

Name: The name of this corporation is:

under the laws of the United States and the State of Florida.

of one class, with a Par Value of one dollar each.

ARTICLE XIII


Informal action of directors: If all of the directors severally or collectively consent in writing to any action taken by the corporation, and the writing evidencing such consent is filed with the secretary of the corporation, such action shall be as valid as though it had been authorized at a formal meeting of the board of directors.

ARTICLE XIV

Preemptive rights: Every shareholder, upon the sale for cash or otherwise, of any new unissued stock of the corporation of the same kind, class or series as that which he already owns and holds, shall have the right to purchase his pro rata share thereof at the same price and terms at which it is offered to others.
