ARTICLES OF INCORPORATION OF

ARTICLE I Name of Corporation

The name of this corporation is RAWK INVESTMENT INC.

ARTICLE II Purpose

Organized primarily as an investment portfolio, RAWK INVESTMENT INC. will, with the approval of its Board, transact any and all lawful business permitted under the laws of the United States and the State of Florida.
