To borrow money and contract debts when necessary for the transaction of its business or for the exercise of its corporate rights, privileges or franchises, of any other lawful purposes; to issue bonds, promissory notes, bills or exchange, debentures and other obligations and evidences of indebtedness, payable at a specified time or times secured by mortgage or otherwise.

D. To guarantee, purchase, hold, sell, assign, transfer, mortgage, pledge or otherwise dispose of the shares of stock of, or any bonds secured or evidence of indebtedness created by any other corporation or corporations and while owning said stock to exercise all rights, powers and privileges or ownership, including the right to vote thereon.

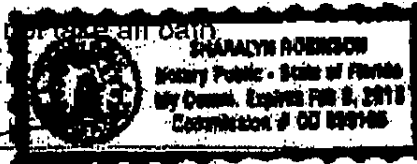



