Articles of Incorporation of Florital Cobreeding, Inc.

The undersigned incorporator files these articles on behalf of the shareholders of the Corporation all in accordance with Chapter 607 of the Florida Statutes

ARTICLE I NAME

The name of the Corporation shall be Florital Cobreeding, Inc.

ARTICLE II PRINCIPAL OFFICE MAILING ADDRESS

The principal place of business and mailing address of this Corporation shall be PO Box 252, 125 Tanner Road, Felda, Florida 33930.

ARTICLE III SHARES

The shares of the Corporation shall consist of a single class of no par value common stock which shall be divided further in to Series A voting Shares and Series B non-voting Shares. The Corporation is authorized to issue up to a total of One Hundred Thousand (100,000) shares of no par value common stock. The Corporation is authorized to issue up to Ten Thousand (10,000) shares of Series A voting shares and Ninety Thousand (90,000) shares of Series B non-voting shares.

Up to \$50,000 dollars in value of the common stock issued shall be designated as \$1244 stock by the directors.

ARTICLE IV S CORPORATION ELECTION

The Corporation shall make an election to become an S corporation under §1362(a) of the Internal Revenue Code. No shares of this Corporation shall be issued to or transferred to a person who is not a qualified S Corporation Shareholder.

ARTICLE V INDEMNIFICATION

The Corporation shall indemnify to the fullest extent permitted by the Florida Business Corporation Act any person who has been made, or is threatened to be made, a party to an action, suit, or proceeding, whether civil, criminal, administrative, investigative, or otherwise (including an action, suit, or proceeding by or in the right of the Corporation), by reason of the fact that the person is or was a director or officer of the Corporation, or a fiduciary within the meaning of the Employee Retirement Income Security Act of 1974 with respect to an employee benefit plan of the Corporation, or serves or served at the request of the Corporation as a

director, or as an officer, or as a fiduciary of an employee benefit plan, of another corporation, partnership, joint venture, trust, or other enterprise. In addition, the Corporation shall pay for or reimburse any expenses incurred by such persons who are parties to such proceedings, in advance of the final disposition of such proceedings, to the full extent permitted by the Florida Business Corporation Act.

ARTICLE VI INITIAL DIRECTORS

The corporation shall have a minimum of one (1) director.

The Directors by majority vote shall have the sole right to amend or repeal any provisions contained in these Articles of Incorporation, the Bylaws of the Corporation, or any amendment thereto.
