The undersigned incorporator fries these articles on behalf of the shareholders of the Corporation all in accordance with Chapter 607 of the Florida Statutes

ARTICLE I NAME

The name of the Corporation shall be Original Beauty Farms, Inc.

#### ARTICLE II PRINCIPAL OFFICE MAILING ADDRESS
