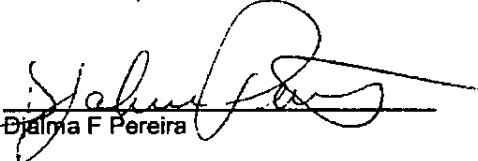

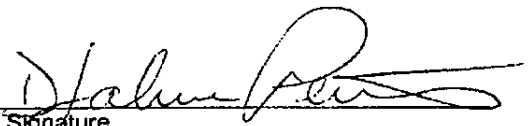

The amendments were adopted by the shareholders. The number of votes casted for the amendments by the shareholders were sufficient for approval.

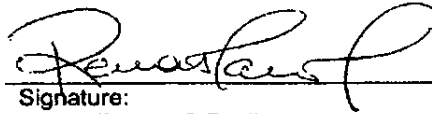
