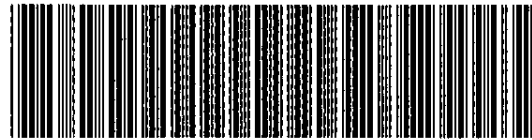



ARTICLE I. NAME

The name of this corporation is FLOORING EDICATE, INC.

ARTICLE II. DURATION






