

ARTICLES OF INCORPORATION

OF

TJS INTERNATIONAL, INC.

The undersigned, acting as incorporator under the provisions of the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of this corporation is:

TJS INTERNATIONAL, INC.

ARTICLE IV. TERM OF EXISTENCE

The corporation is to exist perpetually.






