**ARTICLES OF INCORPORATION
OF
LIVdecor, INC.**

ARTICLE I - NAME, PRINCIPAL ADDRESS AND MAILING ADDRESS

The name of the Corporation shall be LIVdecor, INC. The principal and mailing address of the corporation shall be 1303 N. Armenia Ave., Tampa, FL 33607-5310.

ARTICLE II - CAPITAL STOCK




