**ARTICLES OF INCORPORATION
OF
AXIOCHEM USA, INC.**

I, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following *Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.*

The name and initial address of this Corporation shall be: AxioChem USA, Inc., c/o Kenneth G. Mather, Broad and Cassel, 100 N. Tampa Street, Tampa, Florida 33602, with the privilege of having its offices and branch offices at other places within or without the State of Florida.

This Corporation may engage in any activity or business permitted under the laws of the State of Florida.

The capital stock authorized, the par value thereof, and the characteristics of such stock are:

The consideration for said stock shall be payable in cash, property, real or personal, labor or services in lieu of cash, at a just valuation to be fixed by the Board of Directors of this Corporation.

This Corporation shall commence its existence immediately upon the filing of these *Articles of Incorporation*, and shall exist perpetually thereafter unless sooner dissolved according to law.

The initial registered office of this Corporation is c/o Kenneth G. Mather, Esquire, 100 North Tampa Street, Suite 3500, Tampa, Florida 33602. The initial registered agent at that address is Kenneth G. Mather, Esquire.

The Corporation shall have one (1) director initially. The names and address of the initial director of the Corporation, who shall hold office for the first year or until their successors are duly elected and qualified is:

No contract or other transaction between this Corporation and any other corporation, and no act of this Corporation, shall in any way be affected or invalidated by the fact that any of the

directors of this Corporation are pecuniary or otherwise interested in, or are directors or officers of, such other corporation. Any director individually, or any firm of which any director may be a member, may be a party to, or may be pecuniary or otherwise interested in, any contract or transaction of this Corporation, provided that the fact that he or such firm is so interested shall be disclosed or shall have been known to the Board of Directors or a majority thereof, and any director of this Corporation who is also a director or an officer of such other corporation, or who is so interested, may be counted in determining the existence of a quorum at any meeting of the Board of Directors of this Corporation which shall authorize any such contract or transaction with like force and effect as if he were not such a director or officer of such other corporation, or no so interested.

The private property of the shareholders shall not be subject to payment of the corporate debts to any extent.

This Corporation may indemnify and insure its officers and directors to the fullest extent permitted by law.

This Corporation expressly elects not to be governed by either Section 607.0901 or Section 607.0902 of the Florida Business Corporation Act, as each may be amended from time to time, which sections relate to affiliated transactions and control share acquisitions.
