ARTICLES OF INCORPORATION OF EIGENCHEM TECHNOLOGIES INC.

ARTICLE VII. INDEMNIFICATION

- A. - F. If any provision in this Article shall be invalid, illegal, or unenforceable, the validity, legality, and enforceability of the remaining provisions shall not in any way be affected
