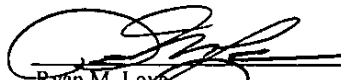
**ARTICLE XI. INDEMNIFICATION.**

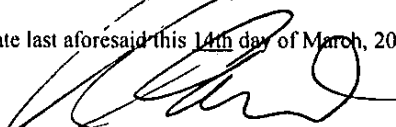
