# ARTICLES OF INCORPORATION OF

## Accountants and Business Advisors for Physicians, Inc.

The undersigned, acting as an Incorporator of a corporation under the Figure Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

#### **ARTICLE I - Name**

The name of the corporation is: Accountants and Business Advisors for Physicians, Inc.

## **ARTICLE II - Principal Office and Mailing Address**

The mailing address of the principal office is: 2631-A N.W. 41st Street, Gainesville, FL 32606.

#### **ARTICLE III - Shares**

The corporation is authorized to issue One Hundred (100) shares. The par value is \$1.00 per share. Each share of stock shall be entitled to one (1) vote, and in the election of  $\ddot{\alpha}$  irectors of the corporation, the holders of the stock shall be entitled to vote their stock cumulatively.

This right may also be waived by affirmative written waiver submitted by the shareholder to the corporation within thirty (30) days of receipt of notice from the corporation.
